Water Distribution Operators in Local 9 Reach TA

Newly organized members of Local 9 – City of Minneapolis secured a tentative agreement (TA) this week. These employees, who work as water distribution operators, were previously organized with a different union but decided to join AFSCME in the last year. The TA also increases longevity and premiums by 2.5% each year and adds a weekend day shift to the shift differential, ensuring that workers are compensated if they need to work on a weekend.

This TA – and the process of securing it – went a long way to build union power. It increases the number of stewards to 1 per 25 employees in the bargaining unit, boosting collective power. Five members of the bargaining team participated in contract negotiations for the first time, further building power and knowledge within Local 9.

Scott County (Local 2440) Reaches TA

Earlier this month, members at Scott County reached a TA for a three year contract that secures wage increases and benefits for all their members. The TA includes wage increases of 2.75%, 2.5%, and 2.75% for the

corresponding years of the contract.

Members on the negotiating team won big advances in benefits as well. The TA increases the max amount of PTO hours from 432 to 480, shortens the PTO accrual rate steps, and adds five hours to every employee's PTO bank on March 2, 2020. The committee also secured one week of paid parental leave, adding this as a benefit for the first time. The TA also increases a differential rate by \$.25.

Local 2440 is recommending the agreement to the membership. Scott County – mark your calendars for the ratification vote! On-site voting will take place on February 11-12.

In February 2020, MSRS will conduct an election to fill four positions on the MSRS Board of Directors.

On Wednesday, February 5, ballots will be mailed to eligible voters.

Monday, March 2 is the deadline to vote. Votes will be tallied on Thursday, March 19, and results will be announced at msrs.state.mn.us shortly after.
