### **HCMC** Workers (Local 2474) Reach a TA after Worker Action

Last month, workers at Hennepin County Medical Center (HCMC) marched in an informational picket to demand a fair contract and to protect their dental plan for future hires. The picket came after negotiations stalled with management, who seemed determined to "sunset" the workers' dental plan for employees who start in 2021.

L2474 members refused to negotiate away benefits for future workers and fought back hard. They held the picket line for hours in freezing temperatures outside the HCMC Specialty Care building.

This week, management finally caved, and L2474 members secured a TA that would protect the dental trust. They also secured a 2.25% raise in 2020 and another 2.25% raise in 2021.

When we fight, we win congratulations, siblings!

### Greater Minneapolis Crisis Nursery workers (L3481) Reach TA

AFSCME members at the Greater Minneapolis Crisis Nursery perform an essential service in their community: these workers care for children and infants who can't be with their families due to crises in their homes. This week, after a protracted negotiation process, members secured a TA with guaranteed raises, better pay language, and boosts to worker safety.

At the opening of negotiations, management proposed cuts to PTO accruals, bereavement leave, and

offering next to nothing in wage adjustments. The L3481 negotiation team eventually went into mediation in search of a fair contract. Meanwhile, AFSCME members and worker allies signed a petition in support of these members and their incredible work.

Finally, the negotiations team secured a contract through mid-2022 that includes a 2% retroactive raise, a 1.15% raise in July 2020, and another 1% raise to follow. Wage boosts also include a raise to shift differentials and a new wage grid, increasing all workers by 25 cents.

The contract also adds language increasing worker safety and securing PTO cashout, union leave, and callback pay.

Thanks to all union siblings who signed the petition and supported the L3481 workers. Congratulations to our powerful siblings at the Greater Minneapolis Crisis Nursery!

### Participate in the DFL Caucus!

For the first time in many years, Minnesota will use a primary election instead of precinct caucuses to determine how the state's delegates vote at the presidential nominating conventions. But don't forget: precinct caucuses are still happening, and they are more important than ever.

#### The 2020 precinct caucuses will be held THIS TUESDAY, February 25 at **7PM**.

Though participants will not be voting on a presidential candidate until March 3, your voice is needed to make sure that labor champions for state and local office win the DFL nomination. Check out all AFSCME Council 5's endorsed candidates at afscmemn.org.
