In Absence of Federal Action, AFSCME Members Step Up to Make Homemade PPE

The COVID-19 pandemic has made it clear: front line workers are essential. But in the face of unprecedented danger, the federal government has failed to protect these workers.

n the absence of drastic federal action, workers will go without the essential PPE they need - unless we pitch in to help. Across the region, Minnesotans are heeding the call to fill the gap left by federal inaction. Last week, Governor Tim Walz Homemade Mask Week, and thousands of masks were delivered to local fire departments across the state to be delivered to congregate living facilities.

"While homemade masks will not replace personal protective equipment, they go a long way in preventing the wearer's germs from infecting others," said Governor Walz.

Despite the many masks delivered last weekend, vulnerable neighbors and front-line workers still need PPE. Luckily, AFSCME members were ready to answer the call!

"This is what we as union members are called to do," Dusosky said: "Act." But she needed more help to make and distribute the masks.

That is where Judi Shurson from Local 2474 came in. Dusosky, Shurson, and others broadened the distribution network to include correctional officers and hospital staff. So far, the members have made 150 masks and 400 ear guards, and will continue making more.

"These masks are made with love," said Shurson. "It's a way of giving a

In the Northland, Local 66 members who work as educational assistants in School District #709 (Duluth) are making and distributing PPE for their members. Not only are they making masks; they are also crafting t-shirts that create awareness and help others understand social distancing.

The CDC recommends wearing cloth face coverings to reduce the transmission of COVID-19 in our communities.

Governor Walz, U of M, and Mayo Clinic Announce Breakthrough in COVID-19 Testing

Representatives from the University of Minnesota, the Mayo Clinic, and representatives of the state's largest health care systems joined Governor Tim Walz to announce that their collaborative efforts have lead to a breakthrough in the search for fast, affordable COVID-19 testing.

These efforts could test as many as 20,000 Minnesotans per day once the system is running at capacity. The increase in testing and tracing will help improve control of the COVID-19 epidemic and support the safe and science-based re-opening of businesses and our communities.

Leveraging the state's healthcare system means Minnesota could lead the nation - and perhaps even the world in testing capacity.

Funded in part by \$36 million from the COVID-19 Minnesota Fund, partners will launch a statewide strategy to test all symptomatic people, isolate confirmed cases, and expand public health surveillance tools. A virtual command center will monitor daily testing needs and coordinate rapid responses to outbreaks.

At AFSCME Council 5, we're grateful for our members at all of the partner organizations who make this collaborative effort possible. Members at Hennepin Healthcare (HCMC) are doing amazing work by building out an infrastructure large enough to support testing and treatment on this scale.

Minnesotans have risen to the challenge. With careful preparation, diligent effort, and unity, we will get through this pandemic together.
