## Judicial Branch Employees Fight for Paid Family Leave

AFSCME members in the Judicial Branch are state employees, but unlike their counterparts in the Executive Branch, they do not have Paid Family Leave benefits.

In 2016, we won a big victory when then-Governor Mark Dayton announced a plan to provide up to six weeks of paid parental leave to all state employees. But somehow in this process, Judicial Branch employees — the vast majority of whom are women — were left out.

The lack of Paid Family Leave is only part of the problem. In general, employees in the Judicial Branch have less generous compensation plans and benefit packages than similar roles in the Executive Branch. Their contracts are administered by a small group of appointees called the Judicial

Council and implemented by a Court Administrator through an opaque process. This lack of transparency provides cover for bureaucrats to deny paid leave benefits.

That's why we're calling out the unfairness of Judicial Branch employees being denied a benefit that was promised to them nearly three years ago. All Minnesotans deserve paid time to care for themselves and their families – and these workers can get it, as soon as bureaucrats allow the process to move forward.

The next round of negotiations will begin in early July. We hope to encourage management to engage in a good faith effort to keep the State of Minnesota's promise to all state employees.

### Local 753 Food Service Workers Ratify Contract

Local 753 Chartwells food service workers at St. Cloud State University overwhelmingly voted to ratify their new contract last week.

The contract includes wage increases across the board, an agreement to meet and confer with the employer on issues

that arise during the life of the contract, and improved vacation, sick leave and bereavement language. The team also fought to fix the previous contract's wage grid to give a clear description of starting wages for each year.

## **Local 722 Regions Service Workers** Reach Tentative Agreement

Regions Hospital service workers at Local 722 reached a tentative agreement on a new contract last week. Local 722 members will hold a ratification vote on Friday, July 12.

The TA includes a general wage increase: members will receive a 2.25% raise starting July 1, 2019 and a 2% raise on July 1, 2020.

The salary range minimum and maximums will increase by the same percentages as the general increase for both years. The TA also includes increased evening and overnight shift differentials, a boosted merit matrix, and better language overall.
