AFSCME Council 5 Opposes Proposed Plan to Close DOC Facilities

The Minnesota Department of Corrections announced this week that they plan to shutter two correctional facilities - Togo and Willow River - as early as next year.

If implemented, this plan will force one hundred AFSCME members out of their jobs - just when working families can least afford to lose their livelihoods.

"These workers are on our front lines and deserve our thanks and admiration for their work, not layoff notices," said AFSCME Council 5 Executive Director Julie Bleyhl.

Even DOC Commissioner Paul Schnell acknowledges that the timing of these layoffs is "brutal".

In addition, these closures will deprive inmates of the rehabilitation services that are the center of the programming at Togo and Willow River. Both facilities operate Minnesota's Challenge Incarceration Program, a minimum security boot camp program that allows nonviolent offenders who qualify to earn early release. Transitioning these programs to other facilities will delay or even restrict inmates' access to the opportunity to turn their lives around. "The Challenge Incarceration Program remains one of our state's most effective programs to reduce recidivism and prison re-entry," said Bleyhl.

The DOC reports that it faces a \$14 million budget deficit and uses this shortfall as justification for these closures.

This budget deficit exists because Republicans in the Minnesota Legislature refused to even consider a supplemental budget request during the last special session to close these funding gaps and ensure that public services for Minnesotans would continue uninterrupted.

This will not be the last time that government inaction harms working families. At the state and federal level, Republicans are refusing to take action to fund the front lines and ensure all Americans have the support they need during this challenging time.

We know that the COVID-19 pandemic and the resulting economic fallout will continue to force state and local governments to make hard choices. afscmemn.org

But as we navigate these unprecedented times, we must not balance our budgets on the backs of public employees and the communities they serve.

"We will continue to mobilize our members to take action to prevent further layoffs or service delays," said Bleyhl. "Public safety and facility security are our members' number one goal."

Pressure Intensifies on Congress to Pass HEROES Act

For weeks, working families and their allies have been pushing Congress to pass the HEROES Act, a bold response to stabilize our economy and help families survive the health and economic harm caused by COVID-19.

The HEROES Act would provide nearly \$1 trillion in immediate and essential aid to American families and the public programs that serve them.

This aid is even more essential than it was when the House passed it a month ago. While Senate Republicans dragged their feet and wasted precious time, working families spent down their emergency savings and the economy moved closer to disaster.

Even when they finally got around to doing their jobs, the GOP proposal to address the COVID-19 crisis fell far short of what America needs.

"The economy is cratering. State and local governments are in a state of fiscal collapse. Public service workers are getting pink slips, even though their life-saving work is needed now more than ever," said AFSCME President Lee Saunders.

"The Senate proposal introduced today does nothing to address these converging crises. It instead focuses on protecting corporations while abandoning working people, and is seemingly content to let state and local governments go bankrupt."

As the situation becomes more dire, AFSCME members have only gotten louder. Across the country, our union siblings have called their Senators, written letters to local papers, and organized their coworkers and families to fight alongside them.

All of our organizing efforts are working; recent polling shows that the vast majority of Americans support significant federal aid for states and localities to maintain vital public services. No fewer than seven in 10 voters polled in seven swing states support \$1 trillion in federal aid to prevent cuts to public services. Capitol Hill reporting suggests that vulnerable GOP Senators are worried that their party's failure to lead is hurting their shot at reelection.

Our advocacy is working. We can't let up now. Send a message to the US Senate: do your job, or face the consequences in November.

As public employees, we know how many of our neighbors rely on the services we provide. We can't risk more lives

by slashing essential public services. To beat the virus and put our economy back together, the federal government must act.

Tell the Senate to pass the HEROES Act now by texting FUND to 237-263.
