Local 495, City of Columbia Heights, ratified a three-year contract that includes increased employer contributions towards insurance premiums and health savings accounts through 2021, plus wage increases totaling 3 percent for each year of the contract. The local also successfully incorporated the addition of a new floating holiday that can be used on either Good Friday or EID Al-Fidha.

Legislative Update

The 2019 Minnesota legislative session is just getting started, but the action is heating up!

Paid Family Leave: As members of the Minnesotans for Paid Family Leave coalition, we're excited to stand with Sen. Susan Kent and Rep. Laurie Halverson, who are authoring a bill to make sure every working Minnesotan has the ability to take time off when they're sick, unsafe, or need to care for their loved ones. At a press conference Tuesday, working Minnesotans joined the bill's authors and House Speaker Melissa Hortman in outlining the details of the bill and illustrating how its passage will improve lives and strengthen our communities across the state. We're proud to support paid family leave legislation that includes provisions for survivors of domestic violence.

Private Prisons: A bill to reopen the mothballed private prison in Appleton was introduced Tuesday. AFSCME has long opposed human incarceration for profit and will continue to fight back against any efforts to allow for-profit prison corporations to operate in our state. We're committed to passing legislation this year to ban private prisons in Minnesota.
