Voters Elect AFSCME-Endorsed Candidates Across the US

Election Day 2019 was a big victory for working families. Across the country, voters elected pro-worker candidates for state and local government, providing further evidence of growing political momentum for working people. Working families elected candidates who support worker rights, greater access to health care, expanding voting rights, making it easier for workers to form unions, providing quality public services and more.

In Minnesota, the overwhelming majority of AFSCME-endorsed candidates won their elections.

- In a critical special election for Ramsey County District 1, AFSCMEendorsed Nicole Joy Frethem defeated former anti-worker legislator Randy Jessup.
- Bloomington elected pro-labor Tim Busse as Mayor and endorsed candidates Jenna Carter, Dwayne Lowman, and Shawn Nelson to the City Council.
- Six of seven endorsed candidates for St. Paul City Council won their elections, including Nelsie Yang, who became the first Hmong woman to serve on the Council.
- In Duluth, Mayor Emily Larson won a second term, and endorsed candidates Janet Kennedy and Arik Forsman were elected to the Duluth City Council.
- All of the endorsed candidates for school board in St. Paul and two of three endorsed candidates in Duluth won their races.

Two notable pro-worker victories outside of Minnesota: Voters in Virginia elected the most pro-worker legislature in a generation, and Kentucky rejected their divisive governor and elected Democrat Andy Beshear, who ran on protecting health care and workers' rights to collectively bargain.

Hundreds of AFSCME members made these victories possible through oneon-one conversations with voters and get-out-the-vote campaigns. But the work is far from over – 2020 will be a turning point in our nation's history, and the results of next year's election will impact our workplaces and communities in countless ways. Rest up, members - we've got a lot of work ahead!

State Bargaining Unit 8 Ratifies Tentative Agreement

After four days of voting at multiple locations, the Unit 8 contract was ratified with an acceptance rate of over ninety (90) percent.

As expected, the "across the board" wage increase aligned with the established pattern, and we won a 2.25 percent increase to wages for each year of the contract, with retro pay back to July 1, 2019. In addition, the new TA includes wage grid modifications to correct pay inequities; starting wages and maximum pay will both increase beginning on January 1, 2020. Additional highlights include an increase to the maximum hours paid to officers injured on duty, and up to four hours paid to officers who must seek medical treatment during or after their shift; no loss of seniority for officers who are absent as a result of onduty injury during probation; and an increase from seven to 10 allowed shift exchanges per month.

The Unit 8 negotiating team has notified Minnesota Management and Budget (MMB), the Bureau of Mediation Services (BMS) and the Department of Corrections (DOC).

Local 3532 Ratifies Contract and MOU

The employees at the Walker Methodist Health Center (Local 3532) ratified a new contract that includes a 2.25% wage increase, a wage boost upon completion of probation, and a perfect attendance incentive for employees. The new contract also codifies members' rights to receive a New Member Orientation (NMO) from their union on their orientation day.

In addition to the contract, Local 3532 secured an MOU with management clarifying that 401k will be consistent with the current employer match benefit given to all Walker Methodist employees. Getting this benefit in writing is a powerful step toward a secure retirement.
