AFSCME Mourns the Passing of Union Sister Rep. Diane Loeffler

Our labor family mourns the death of AFSCME sister and State Rep. Diane Loeffler, who died last week after a battle with cancer. She was 66.

A dedicated and tireless public servant, Rep. Loeffler represented Northeast Minneapolis for 15 years in the Minnesota State Legislature. She dedicated her career to helping our most vulnerable neighbors by providing the high-quality public services we all depend on.

Members who advocated at the Capitol found a willing and eager partner in Loeffler, who was always ready to fight for core services and the public employees who deliver them. She served as chairperson of the Property and Local Tax Division Committee, and also served on the Health and Human Services Policy Committee, among other assignments.

Loeffler was a champion for working families, not just in the Legislature, but also as a public employee and an AFSCME union member herself. She was a member of Local 2864 in her role as a health care policy analyst for Hennepin County, focusing her efforts on services for seniors and people with disabilities, as well as expanding access to affordable health coverage.

A lifetime resident of Northeast Minneapolis, Rep. Loeffler graduated from Edison High School and earned degrees in social science and education from Augsburg College.

Loeffler often described a very personal reason for fighting on behalf of the most vulnerable: her aunt Lil, who was born with Down syndrome. Her aunt's experience taught Rep. Loeffler that government could be a powerful force for good on our community, and it fueled her passion for public policy throughout her life.

The entire AFSCME community mourns the loss of this tireless advocate for working families and sends our deepest condolences to Rep. Loeffler's loved ones.

We asked for expansion of safety and harrasment policies, increased visibility of said policies, and an improved and mandatory sexual harassment training for all Hennepin County employees, with the partnership of the Minneapolis Sexual Violence Center. AFSCME members hav worked with management to construct a Trauma Informed Management checklist, and push the County to move forward in this effort.
