- Cuts hundreds of jobs across state government, including DHS, MDH, and Corrections

- Preemption would be law

Deadline Approaching for Nellie Stone Johnson Scholarships

Applications for the 2019-2020 academic year are now being accepted. The Nellie Stone Johnson Scholarship is available to minority students from union families attending or planning to attend one of the Minnesota State Colleges and Universities System. Minnesota State consists of 30 colleges and 7 universities with 54 campuses throughout the state and offers over 3,800 programs taught by exceptional faculty. To be eligible, a scholarship applicant must be a racial minority and a union member or be the child, grandchild, or spouse of a union member. Scholarships are awarded to both full-time and part-time students who will be attending a Minnesota State tech or community college or state university in the fall of 2019.

Scholarships are given each year to students who enroll in two/four year, undergraduate or graduate programs. Scholarships may be renewed for up to two years for community or technical college programs, up to four years for students working toward a bachelor's degree, and two years for those enrolled in a master's program.
