#### Name: Jared Ecklund Nominated for: Basic / North Where do you work and what do you do?

I work on the first floor of the Northland Office Building in the Land Use Division of the Planning and Community Development Department. I work with landowners within the County on the permitting processes that are required to develop their property. Much of the work I do consists of issuing land use (building) permits and working with landowners on the requirements of the Wetland Conservation Act and other local, state, and federal regulations.

#### How long have you worked for the County?

I have worked with the county for approximately two and a half years. What experience do you have with being involved in our Union?



I try to be involved with our union as much as I can. I have been a member of the Basic Merit Organizing Committee since the fall of 2018 and I attend as many monthly union meetings as my schedule permits.

## Name: Ben Hansen Nominated for: Basic / South Where do you work and what do you do?

I work as a Principal Appraiser within the Duluth Courthouse office of the County Assessor's Department. I knock on strangers' doors, give them a 20-second spiel, and ask to walk through their homes to figure out what it's worth. So my job requires a decent amount of sales analysis, measuring properties, and interacting with (sometimes not very) happy taxpayers.

How long have you worked for the County?

My first day on the job was June 6, 2013.

#### What experience do you have with being involved in our Union?

I have been a full share member almost from the very beginning. I have almost always voted for a strike, given the fact that it seems that our more-tenured coworkers no longer care to take an aggressive stand to keep their pay or benefits. Case in point: over the years, our pay rates have continued to fall behind the rising cost of living--I would fight for our pay to be indexed to inflation instead of crystal-balling a few years' worth of pay into a union contract. (And don't even get me started on how our Sick Leave cap has been obliterated in recent years.)

#### Why do you feel you would be a good team member on the Negotiating Team?

If I'm selected to be on the team, I have no doubt I'll be one of the more aggressive negotiators--but not out of ignorance. Everything needs to have a firm, factual basis. Furthermore, I have a gift for spotting any gray areas in a contract (there are several in ours) and making sure any ambiguities get eliminated through more clear, strong language. Being proactive about such matters will save us a few headaches and misunderstandings later down the line.

#### Where do you work and what do you do?
