Meeting called to order 12:04 p.m.

- 1. Barb and Lynne talked on the budget. See where at for next year.
 - 2016 budget:
 - -Projected \$18,000.
 - -Actual was \$16,000+.
 - -\$1,600 under what thought we'd take in.
 - We had money set aside under international for other training.
 - -Internal/external organizing:
 - Put money in last year but no one went.
 - If not used, it's a cushion.
 - -3 people went to Day on the Hill (\$931).
 - 2017 budget:
 - -\$1,400 training/\$1,500 organizing.
 - -Convention this year is in Duluth.
 - -International Convention in 2018 is in Boston.
 - Recommendation to budget enough for two people to attend.
 - Jane recommended moving \$500 towards convention.
 - -Move \$500 to officer training (now \$1,500) or steward training (now \$1,400), in anticipation of election of new officers.
 - -Duluth convention \$2,000.
 - -Internal/external training \$500.
- 2. Christy talked on the audit
 - Jane and Heidi are taking trustee training for half a day.
- 3. Talk of future of our union.
- 4. Nominations for Elections:
 - Heidi Leedom's term will be up.
 - Steve D. is not going to be a chief steward again.
 - Carol Hanson stepped up and helped Steve D. last year agreed to be nominated for Chief Steward.
 - Jody Johnson still okay as Exempt Chief Steward.
 - Jill A. might shadow as Steward is in Woodbury office has been mentoring.

- Ryan's not running again.
- Kristie Campeau-Perlock is running for Recording Secretary again.
- Christy Harriman will run for Vice President.
- Trustees are the only ones without an annual term.
- Nominations will open at the February 8 General Membership meeting, with Final Nominations and Elections to commence at the March 8 General Membership meeting.
- Lynne will not be at the February meeting (on vacation).
- Someone not running for position needs to take the nominations.
- Someone will need to nominate Lynne and Carol.
- Send out election notice mailed Feb. 21.
- Contested races will have voting on March 15.
